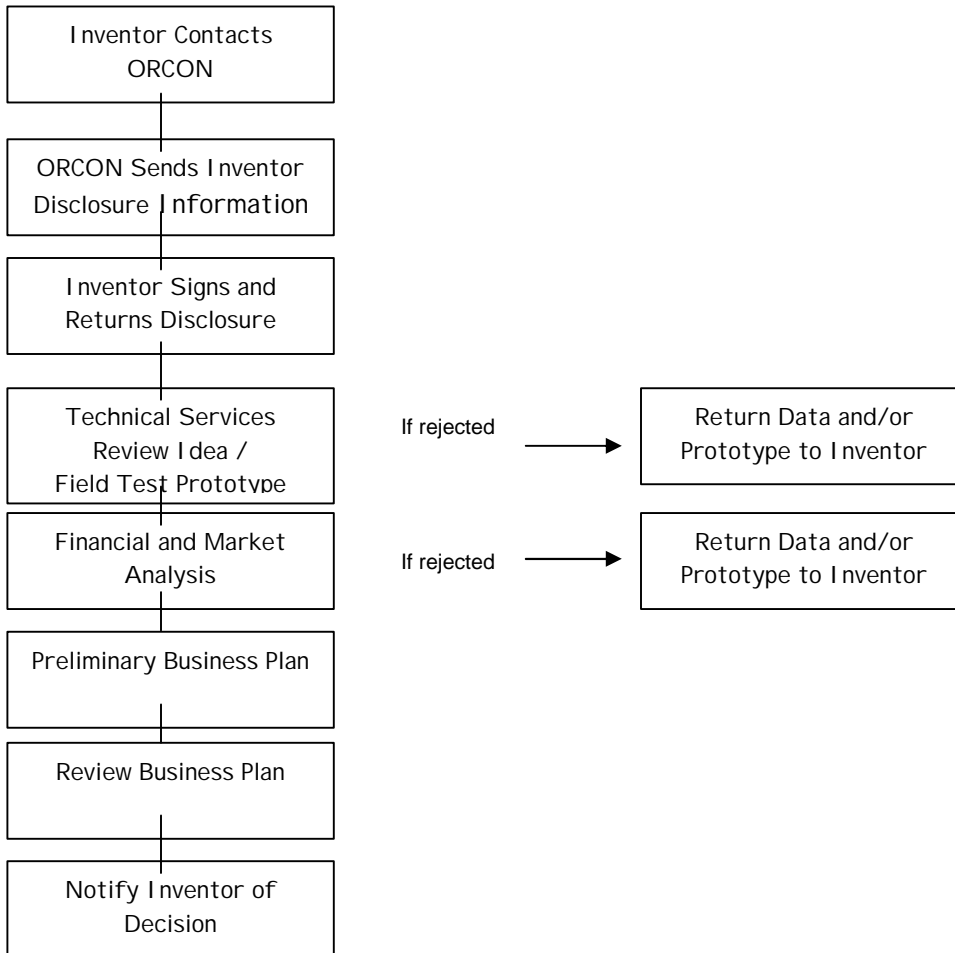

Section 4 Business Agreement

If a favorable decision is reached:

Section 5 Agreement for Submission of an Idea

ORCON Corporation, "ORCON", a manufacturer engaged in the development, production, and sale of products related to tools, products for the installation of flooring, and reinforced film products, has been approached by

for the purpose of having SUBMITTER's idea, invention, or development relating to

(the "IDEA") evaluated to see if the IDEA would be of interest to ORCON. SUBMITTER agrees to disclose the IDEA and ORCON agrees to evaluate the IDEA under the following terms (which shall apply to all disclosures relating to the IDEA).

1. SUBMITTER will provide a written disclosure of the IDEA to ORCON, and may submit models, samples, or other tangible materials relating to the idea.
2. ORCON agrees to use reasonable care to keep disclosure made under this agreement confidential, and agrees not to use or to deliberately disclose to any third person any written or tangible information disclosed under this agreement after this agreement is signed, unless such information:
 - a. Is previously available within ORCON and ORCON can supply proof thereof;
 - b. Is available, or becomes available, from other sources on a lawful and rightful basis; or
 - c. Is within, or later falls within, the public domain.
3. ORCON and SUBMITTER agree that this document sets forth the entire agreement between ORCON and SUBMITTER and that no other promises have been made or rights created other than what is expressly set forth above.
